- 1. Call to Order. Meeting was convened at 2:05 PM.
- 2. Call for nominations for the office of chair. Stephen Adair was nominated for chair. Brief biographical statement, distributed to members prior to the meeting, is below:

Stephen Adair is a Professor of Sociology at CCSU. He received a BA in English from the University of Vermont in 1983, and a PhD from Northeastern University in 1993. He began teaching at CCSU in 1997 after four years in a full-time temporary position at the University of New Hampshire. He served as Department Chair of Sociology from 2007 to 2013 and as Assistant to the Dean of Arts and Sciences from 2003 to 2007 (a half-time administrative/half-time teaching position), in which he represented the Dean's Office in matters related to new programs, curriculum changes, assessment, formal accreditation, and interdisciplinary programs. He has served on numerous faculty committees including Promotion and Tenure, Curriculum, General Education (Chair), Sabbatical Leave, Assessment, and is currently a member of the CSU-AAUP Council. He was Chair of the Faculty Advisory Committee to the Board of Regents in 2012 and Vice-Chair in 2013. He won CCSU's excellence in teaching award in 2002 and has published numerous articles on social inequality and social theory. The priority for the second term of the FAC remains unchanged: Insure effective faculty participation and engagement in matters of shared governance for public higher education in Connecticut.

T.J. Barber

As the Director of Student Activities at Manchester Community College (MCC) I am immersed in governance (both on campus and system-wide) on a daily basis. I earned my BA in Political Science from the University of Texas at Arlington in 1999 and an MS in Educational Leadership from CCSU in 2001. Bob Brown TxCC

I graduated with distinction from the University of Virginia with a double major in History and English, and I received the M.A. in History from thevUniversity of Connecticut. I have served at Tunxis Community College for 15 years in a variety of positions in marketing and public information; academic administration; and, for the past 11 years, as a full-time faculty member. I am today professor of History & English at Tunxis. It is a job I love. Prior to my work at Tunxis, I was a Connecticut journalist. I was a reporter, columnist, editorial and/or desk editor at The Hartford Courant, the Journal Inquirer (Manchester), and The Chronicle (Willimantic). I was also editor, responsible for all newsroom operations, of The Bristol Press in the early and mid-1990s.
