#### VII. Budget

- a. Erica Steiner, CFO
  - i. Timing of deliberations, normally we would take our recommendations to the finance committee on March 10<sup>th</sup> meeting, however, it's way too soon. We are

- tentatively scheduling a meeting on March 28<sup>th</sup> then a board meeting on March 29<sup>th</sup>. We would normally bring it to the SAC before we bring it to the board. However there is no time. The Chair will be briefed.
- ii. Costs are largely wages and salaries. Revenue is from the state and fees and tuition. The state is in a poor way so the budget proposal was not kind to our schools. Wages and salaries are going up because the bargaining is up.
- iii. There is no intention to balance the budget on the backs of the students.
- iv. The BOR is advocating at the legislature, so there's a lot happening on the students behalf.
- v. We firmly believe in transparency. Our fiscal records are open. I will share with you any information you would like.
- vi. We can't speculate on an increase at this point.
- vii. This year the decisions are hard for the legislature so don't expect some sudden good news at this point. The legislature is wondering where the students are if this issue is so important.
- viii. Does the tuition increase get approved before the budget gets passed? Typically tuition and fees have been a cost containment vehicle. We are working hard to create a more early warning process so students can plan for their education. Because we don't have a bargaining unit in place for the next year, we don't have that this year. Normally we have good estimate from the legislature, we don't have that this year either. So this year is really unknown but we still need to come up with something so schools can do their financial aid packages. We are trying to come up with a policy and stick to it and live within it.
  - ix. Student advocacy is critical. We need to take these conversations back to our colleges and get students involved.

## VIII. Advocacy

- a. Presidential Election Southern's President is resigning and we are in the initial stage of finding a new President. The SAC nominates someone to be on the committee to site on the Presidential search committee. It's the chairs opinion that the SCSU rep appoints the person to sit on the committee. It's important that we have someone from Southern sit on this committee. We are all in agreement on that.
- b. Voter Registration it's important that we get everyone registered to vote.
- c. There's an event next Tuesday at 8:30 am in the old appropriations office (310) the capital and it's a good time to have face to face conversations with the legislature.
- d. President paid a visit to North Western last week but there were a lot of people who showed up even though it was during class time.

## IX. MCC Unites

- a. A student initiative addressing social injustice. There are 12 events that week. Working with students about refugee matters, black lives matter, a workshop on stereotypes. If anyone wants to be involved you should contact the chair and the chair will share with the board a schedule when it becomes available. April 4-8 MCC.
- X. Transfer and articulation website demo of the beta website. We are helping students find out how to manage a degree across community college and CSU's. They would like feedback on how easy it is to use. Send feedback to Jason. We want to get to a place where you can click on links and see the courses offered at your school. The second page lists the courses in general and the final step shows the 60 credits you will have to take at a specific CSU. The URL is <a href="www.ct.edu/tap">www.ct.edu/tap</a>. It will go live on April 4<sup>th</sup>. We are trying not to make it too busy, so it's limited in its ability to tell you how you can switch majors and apply credits. The goal is
