#### **Call to Order:**

Alex Grant called the meeting to order at 10:07 a.m.

### **Introduction:**

- Alex Grant (Chair), Luis Sanchez (Vice Chair), and Oliver Driscoll (Secretary) give brief introductions.

#### **New Business:**

- Alex Grant brings up concern of having classes on election day and it being difficult for students to leave to go vote, (either skip classes to go vote or do not vote).
- Another concern was brought up about in-residence students not having proper information about absentee ballots.
- The idea that no classes should be held on election day was brought up and agreed upon.
- 2023-2024 Calendar of Universal Observances is shared with the committee.
- It is possibly too late for anything to be put into effect for the current observance list, and a standalone proposal could be considered on its own.
- Dumebi Emenyonu (CCC), clarifies that only classes should be shut down and the campuses should remain open.
- Discussion continues to the new law requiring institutions to provide women's hygiene products in bathrooms for free.

- Currently, each institution is handling funding for it on their own.
- The main costs are in dispensers for the product.
- Southern is doing test runs of only having product in the most used/popular bathrooms.
- Each student rep should go back to their respective SGA's and figure out what each institution is doing to comply with the law.
- The next agenda item that was discussed is for the SAC Spring schedule.
- There will be a meeting in January (TBD) to keep momentum into the spring semester.
- Reps will report back about what each institution is doing to follow the hygiene products law, and in addition Reps are encouraged to come up with and share a few tangible projects for the SAC to work on to provide a positive change to each institution.
- Community Colleges will have the opportunity to have representatives in the "Connecticut State" conglomerate more to come on that.
- Community College Tuition Discussion is TBD Angelo will send out more information when he receives it.
- Community College "Timely Care" program was discussed, a version of it is coming to State Universities. Having in person mental health professionals was also discussed.
- Brief discussion about food insecurity.
- Western's financial issues were brought up and some concerns surrounding it.
- Issues with Community College transfer tickets were brought up.
   Certain classes required for the transfer ticket are only taught at 2 of the 12 schools, and they are taught in the traditional way, making it very difficult for most students to complete the transfer ticket requirements.

- Once again SAC elections need to be done earlier (possible in spring for the upcoming year so the SAC committee can be done earlier.
