 - ii. IT/Enrollment/Finances are issues being worked on
 - iii. Dr. Grey was at ECSU yesterday for town hall, they discussed the plans, there was really great insight, lots of faculty were there.
 - iv. They are encouraging every campus to have a student round table after the town hall meeting.
- d. NWCC there aren't issues at this point that students are passionate about
- e. Gateway lack of tutors available for specific subjects, disparity in pricing for 4 credit lab courses (science lab vs. Art lab).
- f. COSC We are concerned about the temporary funding the legislature provided last year to off-set tuition. We need more permanent funding sources.
- g. Regent scholarship program moving forward within the next year for awards given to students who progress from CC's to State Universities within the system
