



BACKGROUND

Pursuant to a pending Board Resolution, the title of Distinguished Professor may be awarded from time to time to recognize individuals of prominence who have made significant academic or otherwise valuable service to a university. The award of such a title allows a University to recognize significant contributions made to students, faculty and the university community by such individuals.

ANALYSIS

The Committee unanimously agreed to recommend that we honor Mr. Freeman with the title Distinguished Professor of International Business.

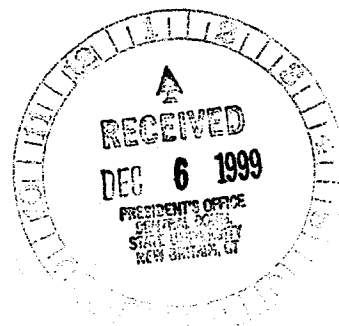

The faculty of the Department of Management and Organization would like to request that Mr. David Freeman, Chairman of Loctite Corporation be appointed as an adjunct member of the department. Mr. Freeman is a 25-year veteran of Loctite Corporation and has recently declined a move to Loctite's new parent company's (Henkel KgaA) headquarters in Dusseldorf Germany. We are fortunate Mr. Freeman choose to continue working and living in Connecticut. Mr. Freeman held several positions in managing Loctite's global operations. According to the Hartford Courant (5/19/99) "he (Mr. Freeman) is considered a key force behind the company's successful expansion in worldwide markets, and steady, likeable executive at home". His considerable business and affable personality will make Mr. Freeman a valued member of the department and the university community. In addition to his work with Loctite, Mr. Freeman is active in Greater Hartford's corporate and civic communities. He serves on the board of directors for Lydall Incorporated, the Mechnics Savings Bank and the Mark Twain House among his many civic endeavors.

I would also like to request that Mr. Freeman be considered for a special academic title. The department believes his business and civic experience merit such consideration. He would be teaching in the area of International Business thus a title such as "Distinguished Professor of International Business" would be appropriate. Accompanying this memorandum is a copy of Mr. Freeman's biography. As you can see his accomplishments are many and we are excited at the prospect of his joining the faculty. I will be available to meet with you or any committee regarding this appointment. Thank you for considering this request.



DAVID FREEMAN

Biography

David Freeman is Chairman of Loctite Corporation and a member of the board of directors of Hartford, Connecticut based Loctite Corporation. Loctite with 1998 sales of approximately \$1 billion, is a manufacturer of high technology sealants and adhesives marketed around the world to industry and consumers.

Born in 1944 in Gateshead, England, he is a fellow of the Institute of Chartered Accountants. After graduation in 1965, he began his career with an engineering company in the northeast of England. Freeman is a graduate of the 1988 Harvard A.M.P.

In 1968 Freeman became the controller of Amoco Chemical's European operations.

He joined Loctite as Financial Director of its U.K. subsidiary based in London in 1974, and advanced to Vice President of the Loctite European Group headquartered in Paris in 1979.

He came to the United States in 1981 as Vice President Finance of Loctite International advancing to Chief Financial Officer of Loctite Corporation in 1983, President of Loctite North American Group in 1985, and Executive Vice President, Chief Operating



Officer and a member of the Loctite board of directors in 1990. He became President of Loctite in 1991 and Chief Executive Officer in 1993, and added the position of Chairman in 1996.

Loctite was acquired by Henkel KGaA in 1997 and following a period of integration, Freeman resigned his Chief Executive role in 1999.

He is a board member of Mechanics Savings Bank, Sealed Air Corporation, Lydall Inc., The Connecticut Business & Industry Association and The National Association of Manufacturers. He is also active in community leadership serving on the board of directors of Junior Achievement of North Central Connecticut, the Urban League of Greater Hartford, and as a trustee of the Mark Twain Memorial in Hartford.
