AUTHORIZING RESOLUTION

concerning

Interim Financing of Central Connecticut State College Parking Facility

October 9, 1970

WHEREAS, The Board of Trustees for the State Colleges has an obligation to make payments to the City of New Britain to cover the amortization of bonds issued to construct the garage and to meet the expenses of operating the facility, and

WHEREAS, The Commissioner of Finance and Control has advised the Board that presently restricted funds within the appropriations of the Board of Trustees for the State Colleges will be made available to meet the Board's commitment to the City of New Britain pending final legislative resolution of the problem, and

WHEREAS, It is understood that the present use of restricted funds within the appropriated operating budget of the State Colleges does not establish a precedent for future use of State College operating budgeted funds to meet the parking facility financial obligation,

BE IT RESOLVED, That subject to the statutory authority granted the Board under Section 10-110 of the 1965 Supplement to the General Statutes, the collection of parking fees at Central Connecticut State College be suspended so as to give the General Assembly the opportunity to formulate policy covering the provision of parking facilities for state institutions, and be it

FURTHER RESOLVED, That presently restricted funds within the 1969-1971 biennial appropriations of the Board of Trustees for the State Colleges be authorized for use in meeting the Board's commitment to the City of New Britain and to meet operating expenses of the parking facility at Central Connecticut State College.

STATEMENT ON PARKING FEE ISSUE
AT CENTRAL CONNECTICUT STATE COLLEGE

Mrs. Bernice C. Niejadlik, Chairman of the Board of Trustees for State Colleges, made the following announcement this afternoon:

" After conferring with President F. Don James, students, faculty, staff and representatives of Governor Dempsey and legislative leaders, I intend to recommend to the Board of Trustees for State Colleges that the collection of parking fees at Central Connecticut State College be suspended. This will give the General Assembly the opportunity to formulate policy covering the provision of parking facilities for state institutions.

The Board of Trustees has an obligation to make payments to the City of New Britain to cover the amortization of bonds issued to construct the garage.

I have been advised by Leo V. Donohue, Commissioner of Finance and Control, that the presently restricted funds within the appropriations of the Board of Trustees for State Colleges will be made available to meet the Board's commitment to the City of New Britain pending final legislative resolution of their problem."
