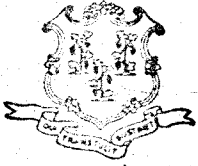

This will acknowledge receipt of Dr. Ritchie's letter of April 9 to Chancellor Hill concerning a proposal for the following program and transmitting the authorizing resolution adopted by the Board of Trustees for the State Colleges on April 6, 1973: Bachelor of Arts in Environmental Science at Eastern Connecticut State College to begin no earlier than September 1973.


As you will recall, this proposal was received for coordination at the March 27 meeting of the Subcommittee on Coordination of Planning and Ad Hoc Planning Committee, contingent on favorable action by the Board of Trustees for State Colleges. Consequently, this program is eligible for joint action by the SCP and Ad Hoc Program Committee at their next regular meeting scheduled Tuesday, April 24 at 9:30 a.m. in the Commission offices.

The proposal does not indicate a subject classification in the USOE HEGIS Taxonomy. The following tentative heading and subheading seem to be appropriate for discussion purposes, but your guidance on this would be welcome:

0400 BIOLOGICAL SCIENCES
0435 Environmental Studies.
