ACQUISITION OF PROPERTY FOR THE NORTHERN BYPASS ROAD AT

CENTRAL CONNECTICUT STATE COLLEGE

December 7, 1973

- WHEREAS, The Board of Trustees for the State Colleges considers the expansion of the physical facilities of the State Colleges a matter of extreme urgency; and
- WHEREAS, The Legislature of the State of Connecticut has appropriated monies for the expansion and construction of new buildings and facilities for the State Colleges; and
- WHEREAS, The Board of Trustees for the State Colleges has found it necessary, for the expansion of Central Connecticut State College, that certain property located in the City of New Britain be acquired; and
- WHEREAS, The Board of Trustees for the State Colleges acting through the Public Works Department of the State of Connecticut as its agent has been unable to successfully negotiate for the acquisition of certain property in the City of New Britain: Therefore, be it
- RESOLVED, That the Board of Trustees for the State Colleges requests the Attorney General of the State of Connecticut to acquire by eminent domain proceedings the following property together with all other parcels of property needed as sites for new buildings and other facilities which monies have been provided and authorized by the General Assembly of the State of Connecticut:
