COVERED BY RESOLUTION #74-12 AND AMENDMENT THERETO



R. Fernandez of Central Connecticut State College and Mr. John Morgan of Bingley College of Education, Bingley, Yorkshire, England. All other conditions specified in former resolutions will prevail.

We have just received a letter from Dr. George Muirhead, our CCSC Professor who was on the Exchange Program during the 1973-74 academic year with Bingley College of Education in England. He has indicated that Bingley College has found it possible to release Mr. Morgan for the entire academic year rather than just the first semester of the 1974-75 academic year as previously approved. Thus Mr. Fernandez of our College will be able to serve in an Exchange Professor capacity for the entire year and has so requested.

This letter then is to request approval by the Personnel Committee of the Board and the Board of Trustees for extending the Approved Exchange Program between Central and Bingley College of Education where Mr. Fernandez of our faculty will teach at Bingley and Mr. Morgan of the Bingley faculty will teach at Central through the entire 1974-75 academic year.

The Board approved this exchange for the first semester of 1974-75 at its May 10 meeting.

FACULTY EXCHANGE

CENTRAL CONNECTICUT STATE COLLEGE

May 5, 1975

WHEREAS, An exchange of teachers with foreign institutions provides enrichment of educational programs, be it

RESOLVED, That under the authority granted by Sections 10-109b and 10-329a of the General Statutes, the Board of Trustees for the State Colleges of Connecticut authorizes an exchange of teachers involving Dr. Justus Beach, Professor of Education at Central Connecticut State College, and Mr. Frank Barrett, Senior Lecturer in the Department of Educational Studies at Bingley College, Bingley, Yorkshire, England. The said exchange to be subject to the following conditions:

- A. The salary of Dr. Beach shall be paid by Central Connecticut State College.
- B. The salary of Mr. Barrett shall be paid by Bingley College.
- C. The exchange shall be for the academic year 1975-76.
