RESOLUTION

concerning

FACULTY EXCHANGE

CENTRAL CONNECTICUT STATE COLLEGE

June 13, 1975

WHEREAS, An exchange of teachers with foreign institutions provides enrichment of educational programs, be it


RESOLVED, That under the authority granted by Sections 10-27, 10-109b and 10-329a of the General Statutes, the Board of Trustees for the State Colleges of Connecticut authorizes an exchange of teachers involving Dr. Justus Beach, Professor of Education at Central Connecticut State College, and Mr. Frank Barrett, Senior Lecturer in the Department of Educational Studies at Bingley College, Bingley, Yorkshire, England. The said exchange to be subject to the following conditions:

- A. The salary of Dr. Beach shall be paid by Central Connecticut State College.
- B. The salary of Mr. Barrett shall be paid by Bingley College.
- C. Transportation, lodging, and other personal expense incurred in the exchange will be fully assumed by the individuals involved.
- D. Mr. Barrett will report to the Chairman of the Department of Curriculum, Research and Supervision of Central Connecticut State College, at the beginning of the fall semester and will assume Dr. Beach's teaching assignments.

Dr. Beach will assume Mr. Barrett's teaching assignments in the area of education and preparation of teachers at Bingley College.

- E. The exchange shall be for the academic year 1975-76.

INTER-INSTITUTIONAL AGREEMENT BETWEEN
BINGLEY COLLEGE OF EDUCATION, BINGLEY, YORKSHIRE, ENGLAND
AND
CENTRAL CONNECTICUT STATE COLLEGE, NEW BRITAIN, CONNECTICUT U.S.A.
ACADEMIC YEAR: 1975/1976

1. An Inter-Institutional Agreement between Bingley College and Central Connecticut State College is intended to provide professional and cultural advantages to faculty/staff members through an exchange program for an academic year.
2. Faculty/staff wishing to participate in the exchange arrangements should consult with the appropriate academic and/or administrative officer for consideration. Applications for exchange will be subject to the respective college administrative authorities.
3. The exchange of one or two faculty/staff members from each college will be considered. Appropriate exchanges may be for the fall semester/autumn term or for the full academic year.
4. Faculty members who will be considered for exchange need not necessarily be lecturers in the same area or department.
5. Faculty members exchanged will be paid their regular salaries by their respective colleges. Where differences are great, the college will attempt to supplement the salaries of the exchanged individual.
6. The Principal of Bingley College and the President of Central Connecticut State College shall each designate a liaison person to complete arrangements.
7. Final arrangements for exchange shall be subject to the approval of the Board of Governors and the Board of Trustees of the colleges.
