concerning

WAIVER OF TUITION FEES FOR VETERANS

November 3, 1978

WHEREAS, The policy of the Board of Trustees for State Colleges, as stated in State College Resolution #74-53a, provides for the waiver of tuition fees only for Vietnam Era veterans, and

WHEREAS, Public Act 78-175 revised Subsection (b)(2) of Section 10-116 of the General Statutes, effective July 1, 1978, to mandate that the Board of Trustees for State Colleges shall waive tuition fees at any of the State Colleges:


...for any veteran having served in time of war, as defined in subsection (a) of section 27-103, who has been accepted for admission to such institution, provided such veteran was a resident of Connecticut at the time he entered the service of the armed forces of the United States or was a resident of Connecticut while so serving and is a resident of Connecticut at the time he is accepted for admission to such institution....,

be it

RESOLVED, That, effective retroactively to July 1, 1978, State College Resolution #74-53a is rescinded, and be it

RESOLVED, That, effective retroactively to July 1, 1978, tuition for qualified veterans shall be waived at the State Colleges in accordance with the provisions of Subsection (b)(2) of Section 10-116 of the General Statutes.
