STUDENTS' OPTIONAL SICKNESS INSURANCE


March 9, 1979

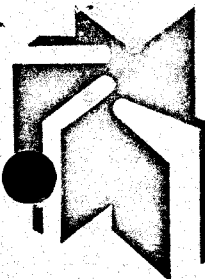

On February 2, 1979, the Trustees adopted the attached resolution providing optional sickness insurance for all full-time students (other than foreign students). The amount of coverage has been substantially increased and the cost has risen from \$31 to \$36 per year.

It is critical that information about this insurance program be transmitted with the first billing so that students and their parents have an opportunity to include it in their financial planning for the Fall.


