COLLEGE ORGANIZATION

September 5, 1980

- WHEREAS, Each of the Connecticut State Colleges now has a College President, a Vice President for Academic Affairs, a Vice President for Administration, and a Dean of Students, and
- WHEREAS, Certain of these positions were in existence prior to the creation of the Board and certain others were created periodically, and
- WHEREAS, It is expedient to regularize and consolidate the authority for the establishment of the principal offices on each of the campuses, therefore, be it
- RESOLVED, That Resolutions #72-26, dated February 4, 1972; #74-3, dated February 1, 1974; #75-59, and #75-60, dated December 5, 1975, be rescinded, and be it
- RESOLVED, That each College shall have a College President who shall be assisted by three principal staff officers as follows: a Vice President for Academic Affairs, a Vice President for Administrative Affairs, and a Dean of Students.




