At a recent meeting, the Board of Higher Education voted an action which affects your institution. A copy of the resolution is attached.

A favorable action for licensure or accreditation is contingent on the appropriate commitment of resources and is subject to the usual ongoing accrediting review by the Board of Higher Education. You are reminded that the regulations require that an application for renewal of licensure or accreditation must be filed at least one year prior to the termination date of the authorization stated in the action. Please note that program accreditation is required before degrees may be conferred in new subject areas. Advanced consultation with my office can reduce the possibility of missing deadlines or can reduce the likelihood of a lapse in authorization.

We wish you success in your efforts and look forward to working with you on the future development of your programs.

At a meeting on October 27, 1981, a quorum being present, the Board of Higher Education voted the following actions:

- (1) authorization of Briarwood College until December 31, 1984, to award credit for instruction given by Briarwood School prior to September, 1976, provided that granting such credit is done in accordance with the plan submitted by the College and consistent with the recommendations of the consultant evaluators; and that the College be further directed to provide a status report on the results of implementing this procedure, said report to be submitted at the time of the College's next application for reaccreditation; 81-A46-P
- (2) licensure of Holy Apostles College to offer four 30 credit hour master's degree level programs in Theology, until August 31, 1984, with a progress report to be submitted by November 30, 1982; 81-A47-I
- (3) licensure of Western Connecticut State College to offer a master's degree level program in Public and Nonprofit Administration until June 30, 1984, with a progress report to be submitted by March 1, 1983; 81-A48-S
- (4) reaccreditation until September 30, 1984, of the teacher preparation programs at the University of Hartford: the undergraduate and graduate programs preparing elementary school teachers grades N-8; the undergraduate and graduate programs preparing secondary school teachers grades 7-12 in the following areas: English, French, Spanish, history, history and social studies, mathematics, biology, chemistry, physics, earth science and general science; the undergraduate and graduate programs in art, music and special education K-12; and the graduate programs preparing reading consultants K-12, guidance counselors, school psychologists and intermediate administrators and supervisors; 81-A49-I
- (5) accreditation of the graduate program in Humanities, leading to the Master of Arts degree at the University of New Haven, until September 1, 1985, and concurrent with institutional accreditation; 81-A50-I
- (6) accreditation of the University of New Haven and its presently authorized programs until September 1, 1985, with a progress report to be submitted by September 1, 1983. 81-A51-I
