RESOLUTION

concerning

AN INCREASE IN FOOD SERVICE FEES

December 3, 1982

WHEREAS, Section 10-116 of the General Statutes provides that the Board of Trustees for State Colleges, subject to the approval of the Board of Higher Education, shall fix fees for such purposes as the Board of Trustees deems necessary, and

WHEREAS, Revenue produced at current rates is not sufficient to cover escalating costs due to inflation, increased rates for fuel and utilities, and salary adjustments, be it

RESOLVED, That, if the Board of Higher Education concurs, effective with the Fall Semester 1983, the charges per participating student for providing food services shall be changed as follows:

RESOLVED, That the Board of Trustees will review the Food Service Fee on an annual basis and will, after discussion with the Student Advisory Board, request changes, if necessary, before March 1 of each year.
