

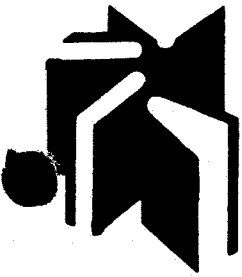

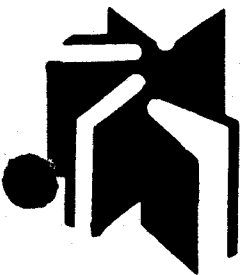

Dear Norma:

I write in response to your letter of December 1. We agree on all points except the 60-day notice. Since I know of no proposal for the creation of new schools the 60-day notice question is of no significance.

The conference on November 17 did enable us to settle issues and avoid problems. Certainly we do not wish to give the appearance of being something we are not. The School of Business Economics has replaced the School of Business and Economics. A copy of the Trustees' Resolution is enclosed.

President Harrison has issued instructions that all college publications carry the proper school title and accurately reflect the programs offered by the College. President Harrison understands that "Southern 2000" and other similar documents are recommendations or proposals and should be so identified. You and I both understand that a document such as "Southern 2000" has no force until it has been approved by our Trustees and by your Board.

The meeting on November 17 went very well, a fact which I attribute to your professional skill and your understanding of the problem.

Dear Jim:

Thank you for meeting with us on November 17 to discuss issues related to the proposed School of Business and Economics at Southern Connecticut State College and the status of "Southern 2000."

The tentative conclusions from our meeting have been confirmed by a telephone conversation between Mark Johnson and Tom Porter on November 22. I understand that you plan to recommend the following course of action to your board on December 3:

- The proposed School of Business and Economics will be renamed the School of Business Economics and efforts to hire a new dean will reflect that change in school designation.
- Southern Connecticut State College plans to seek BHE approval for a major in business administration.
- The BHE staff will process the program request as expeditiously as possible.
- If the BHE/BOG approves the business administration major, the School of Business Economics could be renamed.

A primary basis for this action, as I see it, is a mutual recognition that, at present, SCSC is authorized to offer a bachelor's and master's program in business economics but it is not authorized to offer or advertise programs in business. I am assuming that unless and until such authorization is granted, SCSC will refrain from any public representation of authority to offer programs in business.

With regard to the establishment of any additional new schools at the state colleges, I indicated at our meeting that it would be necessary to follow the 60-day notice requirement in the Board's "Categories of Planning" regulations (10-324-1 through 4). As I recall, you responded that you did not anticipate any additional actions of this sort by your board prior to the establishment of the Board of Governors on March 1.



With regard to "Southern 2000," I believe we agreed that this plan is subject to approval by both the Board of Trustees and the BHE/BOG. I would ask that any future printing and/or edition of this document be clearly represented as a "proposal" or as a "plan subject to approval" by your board and the BHE/BOG. I also would ask that in any future printing and/or edition, each item within the document that is subject to approval be so characterized in the text. I strongly believe that this document must be reviewed and evaluated in the context of state-wide priorities. Therefore, it is essential that the document, and all of its contents, be clearly represented as a "proposal" rather than a "plan."

Please confirm that I have accurately summarized the results of our meeting. Thank you again for your efforts to help resolve these matters.
