January 7, 1983


WHEREAS, Mr. Roy Young, President of the Fairfield Processing Corporation, owner of the property at 190 White Street directly behind a parking lot owned by Western Connecticut State College on the south side of White Street in Danbury, desires to be granted a utility easement along a previously granted contract easement on a commonly used driveway, in order to install a sewer and sewer lines from their property to an intercept located on White Street, and the additional right to install water and electrical services on the same easement if the need arises in the future,

WHEREAS, The Western Connecticut State College administration agrees to the granting of such a utility easement, be it

RESOLVED, That the Board of Trustees for State Colleges authorizes and requests the Commissioner of the Department of Administrative Services to contract with Mr. Roy Young, President of the Fairfield Processing Corporation, 88 Rose Hill Avenue, P. O. Drawer 1157, Danbury, Connecticut, for the granting of a utility easement on a previously granted easement for a commonly used driveway which is approximately two hundred and twenty-five (225) feet in length and twenty-five (25) feet in width, and also be it

RESOLVED, That the Board of Trustees for State Colleges further requests that the State Treasurer execute and deliver the necessary easement documents.
