A GIFT TO EASTERN CONNECTICUT STATE UNIVERSITY

- WHEREAS, Students at Eastern Connecticut State University have conducted various voluntary activities to raise the money necessary to support travel of the University's baseball and softball teams to participate in competition in Hawaii during 1989, and
- WHEREAS, Funds raised in this manner by the students have been deposited in the Eastern Connecticut State University Foundation, and
