RESOLUTION

concerning

COMPREHENSIVE COOPERATIVE EDUCATION FEE
AT
EASTERN CONNECTICUT STATE UNIVERSITY

December 6, 1991

- WHEREAS, Section 10a-99 of the General Statutes provides that the Board of Trustees for Connecticut State University shall fix fees for such purposes as the board of Trustees deems necessary, and
- WHEREAS, The Board of Trustees, under BR#86-140, has established guidelines for the Comprehensive Cooperative Education Programs at the Connecticut State University, and
- WHEREAS, Eastern Connecticut State University has a newly-established Comprehensive Cooperative Education Program that conforms to established guidelines and anticipates that 25 students will participate each semester, and
- WHEREAS, With reduced levels of funding for program costs, Eastern Connecticut State University requests a fee to defray costs associated with the Cooperative Education Program, therefore, be it
- RESOLVED, That, effective with the Fall 1992 semester, Eastern Connecticut State University shall charge a Cooperative Education Fee of \$100 per work block in lieu of tuition and fees, excluding a University General Fee sufficient to defray the cost of student accident insurance and, where necessary, the mandatory student sickness insurance for each student enrolled under the Comprehensive Cooperative Education Program.

GUIDELINES FOR COOPERATIVE EDUCATION PROGRAMS IN THE CONNECTICUT STATE UNIVERSITY

October 3, 1986


WHEREAS, The Board of Governors for Higher Education has encouraged the development or expansion of Cooperative Education programs in public higher education and has invited Connecticut State University to submit a supplemental budget request for fiscal year 1987-88 for that purpose, and

WHEREAS, The Connecticut State University will submit such a supplemental budget request, therefore be it

RESOLVED, that Cooperative Education Programs which will be developed or expanded in the Connecticut State University with general fund support in response to the supplemental budget request for fiscal year 1987-88 and thereafter shall be conducted according to the following guidelines:

1. CO-OP jobs must be for pay.
2. Emphasis will be placed on full-time CO-OP jobs.
3. CO-OP jobs will be evaluated by CO-OP staff to determine their appropriateness as learning experiences.
4. Any academic credit in connection with a CO-OP job experience will be given as a result of an evaluation process participated in and approved by the academic school in which the program being augmented by the work experience is located.
5. CO-OP will be regarded as basically a general fund program and therefore personal services, other expenses, and equipment costs will be sought in general fund budget requests.
6. With the expectation of adequate general fund support for personal services, other expenses and equipment, there will be a modest CO-OP fee charged to students at the beginning of each CO-OP job experience to defray special costs such as conferences, workshops and awards.
