



WHEREAS, Diane L. Cybulski has been selected by the Henry Barnard Foundation to receive its Distinguished Student Award, therefore, be it

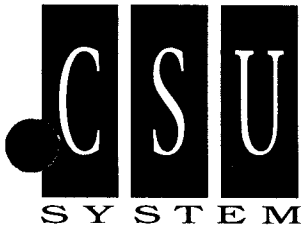
